### Case number format:

- Case Type-Court ID-Four Digit Year-Ending Case Number  
Example case number for Fergus County District Court: DC-14-2022-1
- The **Montana Supreme Court** does not have a court ID. The case number format for Supreme Court cases *only*: DA 22-0123
- The **Montana Water Court** does not have a court ID. The case number format for Water Court cases is Basin Number&Letter-Case Number-Case Subtype Abbreviation-Four Digit Year. Example: 41M-321-P-2021
