If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.


MASTER'S REPORT

FINDINGS OF FACT


- 1. The record owners of stock water claim 41S 140370-00 are Nada Bakos, Harriette Brandon, Henrietta E. Chiappone, and the Whisenhunt Grandchildrens Trust (c/o Nada Bakos).
- 2. Claim 41S 140370-00 was decreed with the point of diversion, reservoir, and place of use located at:

- 3. During examination of the claim, DNRC was unable to locate the claimed reservoir and it placed an issue remark on claim 41S 140370-00 indicating it was unable to locate the reservoir.
- 4. On March 11, 2022, the Claimants submitted an Amendment requesting to modify the point of diversion, reservoir, and point of diversion legal land description, and means of diversion, as follows:



A map was attached to the Amendment showing the location of the reservoir:



The Amendment and attachments are in the 41S 140370-00 claim file.

5. As the Basin 41S Preliminary Decree would be issued soon, an issue remark was added to claim 41S 140370-00, referencing the Amendment.

PRINCIPLES AND CONCLUSIONS OF LAW

- 1. The Water Court must address all issue remarks that appear on a claim as well as any objections the claim receives. Sections 85-2-233, 85-2-247, and 85-2-248, MCA.
- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.
- 3. The proposed legal land description modifications do not have the potential to adversely affect other water users and therefore do not require further notice as provided for in Section 85-2-233(6), MCA. The modifications do not constitute an expansion of the elements of the claim, and merely correct the paper water right; the use of the water right on the ground has not changed.

RECOMMENDATIONS

- 1. Claim 40E 167308-00 should be modified as provided in Finding of Fact No. 3.
 - 2. The issue remarks should be removed from the claim.

A Post Decree Abstract of Water Right Claim is served with the Report for review.
