

DESCRIPTION OF PROPOSED LEGISLATION:

An act repealing Section 19, Chapter 646, Laws of 1989, thereby removing the provision that made the elimination of employment preference provided to veterans and their eligible spouses under the Montana Veterans' and Handicapped Persons' Employment Preference Act temporary until July 1, 1991; and providing an immediate effective date.

ASSUMPTIONS:

1. The costs of administering veterans' and handicapped persons' employment preference would be similar whether section 19 is repealed or remains in effect.
