INTRODUCED BILL

In compliance with a written request, there is hereby submitted a Fiscal Note for HB0031, as introduced.

DESCRIPTION OF PROPOSED LEGISLATION:

This legislation proposes revising the law regarding shooting preserves by establishing a year-round hunting season and eliminating the requirement that persons hunting on shooting preserves have an upland game bird license.

ASSUMPTIONS:

- 1. Licensed shooting preserves will double from 26 to about 50.
- 2. The 150 nonresident and 150 resident hunters which currently utilize shooting preserves also will double to 300 nonresident and 300 resident hunters.
- 3. About 50% of the hunters will hunt only in shooting preserves and will not buy a hunting license. The other 50% of the hunters will hunt in other areas and will continue to purchase a license.
- 4. Because the length of the season will triple and shooting preserve licensees are assumed to double, it is assumed that 0.50 FTE is needed to administer this program within the statutes. Estimates of the FTE costs are based upon average warden costs: Personal services of \$13,268; operations/equipment of \$5,250 for a total of \$18,918 per year.
- 5. To administer licensing of shooting preserves, the department is required by 87-4-528, MCA, to make unscheduled inspections for compliance with the statutes relating to registration of hunters, tagging of game, posting of the preserve boundaries, species which may be hunted and percentage of game recoverable.
- 6. There will be no impact on license revenue since the number of shooting preserves will double but only half of the hunters will purchase licenses.
- 7. Shooting preserve fees will increase from \$2,780 for licensing 24 preserves to \$5,560 for licensing 50 preserves and be deposited in the general license account.
