

STATE OF MONTANA - FISCAL NOTE

In compliance with a written request, there is hereby submitted a Fiscal Note for HB0091, as introduced.

DESCRIPTION OF PROPOSED LEGISLATION:

This bill prohibits a person who receives a moose, mountain goat, or limited mountain sheep special license from receiving another special license for that species for 7 years.

ASSUMPTIONS:

- 1. Drawing and license fees will remain the same.
- 2. Each year there are 1,500 successful applicants for moose, sheep, and goat licenses.
- 3. The Department of Fish, Wildlife, and Parks receives 43,000 applications each year. This number will not change due to new recruitment of applicants and some sportsman that are in a seven year waiting period for one species will start applying for another license.
- 4. Additional expenditures for DFWP include 0.20 FTE for personal service costs of \$3,000 and \$7,000 of operating expenses in FY92. FY93 consists of 0.30 FTE for personal service costs of \$4,500 and \$3,000 of operating expenses. Total additional expenses would be \$10,000 in FY92 and \$7,500 in FY93.
