In compliance with a written request, there is hereby submitted a Fiscal Note for HB0696, second reading.

### DESCRIPTION OF PROPOSED LEGISLATION:

An act extending the funding for the Statewide Genetics program for two years; increasing the fee on health insurers to fund the program; appropriating funding for the program to the Department of Health and Environmental Sciences.

### ASSUMPTIONS:

- 1. The number of Montanans with disability insurance through insurers subject to the genetics program fee in FY90 was 763,785. The number of Montanans with disability insurance in FY92 and FY93 will remain constant.
- 2. The proposed genetics program fee under HB0696 is 75 cents per Montanan with disability insurance.
- 3. There will be 28,931 members in the state health plan and 12,000 members in the university health plan.
- 4. Funding for increased personal services costs is based on aggregate funding estimated in the fiscal note for HB0509 (executive pay plan proposal).
- 5. The biennial appropriation is apportioned equally to FY92 and FY93.
