In compliance with a written request, there is hereby submitted a Fiscal Note for HB0765, as introduced.

DESCRIPTION OF PROPOSED LEGISLATION:

An act requiring that a voter registration form be attached to driver's license applications and vehicle license applications.

ASSUMPTIONS:

Department of Justice:

- 1. Voter registration cards will be furnished by the Secretary of State, in dimensions suitable to the Department of Justice.
- 2. The cards will not be "attached" to the driver's license application form, but will be visibly available.
- 3. The current 625,000 postcard vehicle registration mailers will be mailed in envelopes and the postage required will increase from a postcard rate to first class mail rate.
- 4. Those electing to complete voter registration from vehicle registration mailers will forward them to the county treasurer and not to the Registrar's Bureau in Deer Lodge.

Secretary of State:

- 5. The Secretary of State will prepare a unified driver's license/voter registration form (200,000 forms per year).
- 6. The Secretary of State will pay for publication of voter registration cards to accompany vehicle registration applications (625,000 cards each year).
