4   A BILL FOR AN ACT ENTITLED:   "AN ACT REVISING THE LOCAL  
5   GOVERNMENT LICENSE FEE FOR A BEER OR BEER-AND-WINE LICENSE;  
6   AMENDING SECTION 16-4-503, MCA; AND PROVIDING AN EFFECTIVE  
7   DATE."

9   BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

10       **Section 1.** Section 16-4-503, MCA, is amended to read:

11       \*16-4-503. City and county licenses -- fees. The city  
12   council of any incorporated town or city or the county  
13   commissioners outside of any incorporated town or city may  
14   provide for the issuance of licenses to persons to whom a  
15   retail license has been issued under the provisions of this  
16   code and may fix license fees, not to exceed a sum equal to  
17   ~~five-eighths of the fee for an all-beverages license or 100%~~  
18   ~~of the fee for a beer or beer-and-wine license~~ collected by  
19   the department from such the licensee under this code."

20       NEW SECTION.   **Section 2.** Effective date. [This act] is  
21   effective July 1, 1991.

In compliance with a written request, there is hereby submitted a Fiscal Note for SB0040, as introduced.

DESCRIPTION OF PROPOSED LEGISLATION:

An act revising the local government license fee for a beer or beer-and-wine license.

FISCAL IMPACT:

This bill has no impact on state expenditures or revenues.

EFFECT ON COUNTY OR OTHER LOCAL REVENUES OR EXPENDITURES:

Assumptions for Local Revenue Impact:

1. The number of state licenses in FY 92 and FY 93 will be the same as the number for the 12 month period ending 10/25/90; namely, 1,365 beer and beer/wine licenses. Current state revenue from fees for these licenses is \$478,800 (Liquor Division, Department of Revenue).
2. Every establishment with a state license also has a local license (Montana Tavern Association).
3. All local governments charge the maximum allowable fee for licenses (Montana Tavern Association).
4. The fee for all beer and/or beer-and-wine licenses changes from 100% of the state fee (current law) to 62.5% of the state fee (proposed law).


