In compliance with a written request, there is hereby submitted a Fiscal Note for SB0155, as introduced.

DESCRIPTION OF PROPOSED LEGISLATION:


This bill repeals the annual audit requirement for the agricultural loan authority.

ASSUMPTIONS:

1. Montana Agricultural Loan Authority (MALA) and Beginning Farm Loan Program will remain inactive or enabling statutes will be repealed. Therefore there will be no resulting bond issuance or other activities.
2. The legislative auditor will include the MALA as a part of the Department of Agriculture's audit at no additional expense.
