Section 1. Section 61-5-110, MCA, is amended to read:

"61-5-110. Examination of applicants. (1) The department shall examine every applicant for a driver's license, commercial vehicle operator's endorsement, or motorcycle endorsement, except as otherwise provided in this section. Such examination shall include a test of the applicant's eyesight, his ability to read and understand highway signs regulating, warning, and directing traffic, his knowledge of the traffic laws of this state, and shall include an actual demonstration of ability to exercise ordinary and reasonable control in the operation of a motor vehicle, quadricycle, or motorcycle. The examination for the commercial vehicle operator's endorsement may include additional items.

In compliance with a written request, there is hereby submitted a Fiscal Note for SB0295, as introduced.

DESCRIPTION OF PROPOSED LEGISLATION:

An act requiring the Department of Justice to offer driver licensing examinations on Saturdays.

ASSUMPTIONS:

- 1. Driver exam stations would be closed Mondays in order to be open Saturdays. It is assumed that this would not conflict with statutes requiring state offices to be open Monday-Friday.
- 2. Because most driver exam stations are located in the county courthouses in smaller areas, and courthouses are closed Saturday, the Saturday exams would not be offered in these areas.
- 3. It is assumed that an additional 0.50 FTE Grade 8 Help Desk Clerk will be needed to handle driver license questions routed through the state office on Saturdays, and an additional 0.50 FTE Grade 12 Computer Operator will be needed to perform mainframe computer work on Saturdays. This assumes that the additional staff will be more economical or more practical than payment of overtime to current employees for Saturday coverage.
- 4. Current law is represented by the executive budget base for the Driver Services Bureau of the Department of Justice.
