A BILL FOR AN ACT ENTITLED: "AN ACT AUTHORIZING
MULTIJURISDICTIONAL SERVICE DISTRICTS TO PROVIDE AMBULANCE
SERVICE; AND AMENDING SECTION 7-11-1102, MCA."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Section 7-11-1102, MCA, is amended to read:

"7-11-1102. Services that may be provided. (1) A
multijurisdictional service district may provide only those
services that are authorized to be provided by local
governments.

(2) The services that a multijurisdictional service
district may provide are:

- (a) recreation programs other than park and recreation
programs in a county park district established under Title
7, chapter 16, part 24;
- (b) road, street, and highway maintenance;
- (c) libraries;
- (d) jails; and
- (e) dog control programs; and
- (f) ambulance service."
