DESCRIPTION OF PROPOSED LEGISLATION:

An act to eliminate the gaming advisory council.

ASSUMPTIONS:


1. In FY90, the cost of the Advisory Council (stipends, travel, misc.) was \$9,081. That approximate cost would be expected to continue in the 1993 biennium were the council to remain in existence.
2. Current law is represented by the executive budget base for the Gambling Control Division of the Department of Justice.
