

MINUTES OF THE MEETING
FISH AND GAME COMMITTEE
HOUSE OF REPRESENTATIVES
50TH LEGISLATIVE SESSION

The meeting of the Fish and Game Committee was called to order by Chairman Orval Ellison on February 19, 1987 at 12:30 p.m. in Room 312 of the State Capitol.

ROLL CALL: All committee members were present with the exception of Rep. DeMars, absent, and Reps. Moore and Ream excused.

Rep. Ellison wanted to point out to the committee that HB 526 would not be taken up today. He stated the bill deals with revenue and does not have to meet the transmittal deadline. He wanted to clarify for the committee, so no one would think there was any deceiving practices going on, and doesn't want anyone to think he is holding it up, to purposely kill the bill. He added, there have been several amendments proposed to the bill, and feels extra time is needed to work on this.
