

MINUTES OF THE MEETING  
LOCAL GOVERNMENT COMMITTEE  
50TH LEGISLATIVE SESSION  
HOUSE OF REPRESENTATIVES

March 20, 1987

The meeting of the Local Government Committee was called to order by Chairman Norm Wallin on March 20, 1987, at 1:00 p.m. in Room 312-F of the State Capitol.

ROLL CALL: Roll call was taken with all members present except Rep. Kitselman and Rep. Pistoria who were excused and Rep. Brandewie who was absent. Lee Heiman, Committee Counsel from the Legislative Counsel was also present.

EXECUTIVE ACTION

Chairman Wallin stated the committee was brought in to try to get a vote that was not a tie vote on SB 316. He stated the bill included the amendments that were adopted in the previous meeting. If the bill passed, the amendment would be included. If the bill did not pass, the amendment would be left on the bill.

Rep. Ramirez was present but excused from all voting on SB 316.

Rep. Sales moved that SB 316 BE CONCURRED IN for purpose of amendment. He had a change in the fifth amendment where it stated "jurisdictional area of a city-county planning board under 76-1-505". Rep. Sales stated 76-1-504 should also be included because it actually set up the jurisdictional area and 76-1-505 stated the 4 1/2 miles cannot be gone beyond without petition. He stated he only wanted this to apply to the area that was actually under the city-county planning board jurisdiction.


The question was called on the amendment. The motion carried unanimously.

Rep. Dave Brown moved as a substitute motion to TABLE SB 316. A roll call vote was taken.

Rep. Bulger asked to explain his vote. He stated this was the fifth time the bill had been considered by the committee. He stated he was uncomfortable with the way the bill came before the committee and felt it dealt with a special situation when it should have been for the whole state. He said he would vote to table the bill because five times was too much and privilege had been extended that had not been extended to any other legislation since they had been in session.

The motion carried 9 to 6 to TABLE SB 316.

ADJOURNMENT: There being no further business to come before the committee, the meeting was adjourned.
