The forty-fifth meeting of the State Administration Committee was called to order by Chairman Jack Haffey on March 27, 1987 in Room of the State Capitol at 10:05 a.m.

ROLL CALL: All committee members were present.

GOVERNOR'S APPOINTMENTS: A new set of appointments had been received from the Governor's office dated March 16, 1987. These had been distributed to members of the committee for their consideration and review. The nominations had then been written into Senate Resolution 3 and Senate Resolution 4. The nomination for the State Tax Appeal Board had been separated into SR 4. None of the members of the committee had any concerns with the members who had been nominated to the various boards. Mr. Blake Wordal had withdrawn his name from the Tax Appeal Board on March 25, 1987.

Senator Lynch MOVED THAT SENATE RESOLUTION 4 RELATING TO THE TAX APPEAL APPOINTMENT BE TABLED. The motion passed unanimously.

Senator Lynch then MOVED THAT SENATE RESOLUTION 3 DO PASS. The motion passed unanimously.
