ROLL CALL: All committee members were present except for Senator Lynch and Senator Rasmussen.


CONSIDERATION OF SENATE RESOLUTION 7: This resolution was sponsored by Senator Haffey, Senate District 33, Anaconda, and Senator Bill Farrell, Senate District 31, Missoula, and was entitled, "A RESOLUTION OF THE SENATE OF THE REGULAR SESSION OF THE 59th LEGISLATURE OF THE STATE OF MONTANA CONCURRING IN, CONFIRMING, AND CONSENTING TO THE NOMINATIONS AND APPOINTMENTS MADE BY THE GOVERNOR AND SUBMITTED BY WRITTEN COMMUNICATIONS DATED APRIL 21, 1987, TO THE SENATE PURSUANT TO SECTION 5-5-302, MCA. The committee members has investigated the latest nominations made by the Governor for the new Commissioner of the Department of Labor, the new Director of the Department of Family Services and the new Justice to fill the vacancy on the Supreme Court. All were said to be satisfactory and it was recommended that confirmation be made by the Senate body.

The hearing was CLOSED on Senate Resolution 7.
