They can investigate your complaint and potentially identify information to support your allegations, assist you in filing a complaint of housing discrimination with the Department of Housing and Urban Development (HUD) and/or the Montana Human Rights Bureau (HRB), and under certain circumstances MFH can dispute resolution services prior to the filing of a formal complaint with HUD and/or the HRB.*

## **Statute of Limitations on Complaints/Lawsuits**

*According to MFH, if you think your rights have been violated, you have one year after an alleged violation to file a complaint with the Department of Housing and Urban Development. A complaint must be filed with the Montana Human Rights Bureau within 180 days of the alleged violation.*

A court may award actual and punitive damages and attorney's fees and costs.*
