On September 29, 2023, the Defendant's Application for review of sentence was scheduled to be heard by the Sentence Review Division of the Montana Supreme Court (hereafter "the Division") by Zoom videoconference. Tyler Dugger, Defense Counsel, was present. The State was not present. The Defendant was not present.


Before hearing the application, Judge Wilson stated that the Division was informed by the Yellowstone County Detention Facility (YCDF) the morning of the scheduled hearing, that the Defendant was moved to the Cascade County Detention Facility (CCDF). Detention staff at the CCDF informed the Division that there was no ability for detention staff to make the Defendant available for the hearing.

Mr. Dugger informed the Division that yesterday he went to the YCDF to have a final visit with the Defendant and found that she was no longer a resident. Mr. Dugger was able to call and visit with the Defendant at the CCDF. The Defendant confirmed that she would like to proceed with a sentence review hearing and understood that there was a possibility for delay. Mr. Dugger requested the hearing be continued to the next available round of sentence review hearings.

It is the decision of the Sentence Review Division that due to unforeseen and unavoidable circumstances, the application for review of sentence is **CONTINUED** to the next available hearings on April 5, 2024. Notification will be sent to interested parties four weeks prior providing the actual time and date of the hearing.
