On September 29, 2023, the Defendant's Application for review of sentence was scheduled to be heard by the Sentence Review Division of the Montana Supreme Court (hereafter "the Division") by Zoom videoconference. The Defendant appeared from the Elkhorn Treatment Facility and was represented by Tyler Dugger. The State was not represented.

At the outset of the hearing, Defense Counsel informed the Division that after final consultation with the Defendant, she elected to waive her sentence Review hearing. Mr. Dugger made an oral motion to vacate the Sentence Review hearing and dismiss with prejudice the Defendant's Application for Review of Sentence. The Defendant verbally verified her desire to waive her right to sentence review.

Therefore, it is the unanimous decision of the Sentence Review Division that the Defendant WAIVED her right to sentence review and her Application is **DISMISSED WITH PREJUDICE**.
