On August 3, 2023, the Defendant's Application for review of sentence was scheduled to be heard by the Sentence Review Division of the Montana Supreme Court (hereafter "the Division") by Zoom videoconference. The Defendant appeared from the Crossroads Correctional Center and was represented by Teal Mittelstadt, Defense Counsel. The State was not represented.

Before hearing the application, Ms. Mittelstadt informed the Division she was unable to sufficiently meet with the Defendant prior to the hearing, though numerous attempts to arrange a meeting were made by counsel. Ms. Mittelstadt asked that the sentence review hearing be continued to the next available set of hearings to have sufficient time to meet with the Defendant and properly prepare his case. The Defendant agreed to continue his hearing.

IT IS ORDERED that the Defendant's sentence review hearing is **CONTINUED** to the next available hearings on November 2 – 3, 2023. Notification will be sent to interested parties at least thirty (30) days prior providing the actual time and date of the hearing.


