

On February 2, 2024, the Defendant's Application for review of sentence was scheduled to be heard by the Sentence Review Division of the Montana Supreme Court (hereafter "the Division") by Zoom videoconference. The Defendant appeared from the Montana State Prison and was represented by Rufus Peace, Defense Counsel. The State was not represented.

Before hearing the application, Mr. Peace informed the Division that the Defendant filed an Application for Review of Sentence and had included the above-referenced cause number and another case number. However, the second number listed was the incorrect cause number. Defense asked that the sentence review hearing be continued to the next available set of hearings so that both correct cause numbers may be reviewed at the same time. Daniel Guzynski, Assistant Attorney General, was contacted prior to the hearing and he stated he had no objection to the continuance.

IT IS ORDERED that the Defendant's sentence review hearing is **CONTINUED** to the next available hearings on May 2 – 3, 2024. Notification will be sent to interested parties at least thirty (30) days prior providing the actual time and date of the hearing.
