November 14, 2024, the Defendant's Application for review of sentence was scheduled to be heard by the Sentence Review Division of the Montana Supreme Court (hereafter "the Division") by Zoom videoconference. The Defendant appeared from the Montana State Prison and was represented by Scotti Ramberg, Defense Counsel. The State was not represented.

Before hearing the application, the Defendant requested additional time to visit with Ms. Ramberg about his case. Ms. Ramberg informed the Division that she had talked at length with the Defendant, and there's apparently a miscommunication regarding a mediation that occurred. Per request of the Defendant, and the need to contact prior counsel about the mediation, Ms. Ramberg requested the hearing be continued to the next round of hearings.

It is the unanimous decision of the Sentence Review Division that the application for review of sentence is **CONTINUED** to the next available hearings on February 6 - 7, 2025 to allow counsel time to meet with prior counsel and the Defendant. Notification will be sent to interested parties four weeks prior providing the actual time and date of the hearing.
