On November 14, 2024, the Defendant's Application for review of sentence was scheduled to be heard by the Sentence Review Division of the Montana Supreme Court (hereafter "the Division") by Zoom videoconference. The Defendant appeared from the Crossroads Correctional Center and was represented by David Merchant, Defense Counsel. The State was represented by Thorin Geist.

Before hearing the application, Mr. Merchant informed the Division that he was attempting to schedule a meeting with the Defendant with the Saguaro Correctional Center in Eloy, Arizona, but realized that the Defendant is currently at the Crossroads Correctional Center in Shelby. Mr. Merchant requested the hearing be continued to the next round of hearings to have further discussion with the Defendant to prepare for the hearing. The Defendant agreed to continuing the hearing.

It is the unanimous decision of the Sentence Review Division that the application for review of sentence is **CONTINUED** to the next available hearings that are set for February 6 - 7, 2025. Notification will be sent to interested parties four weeks prior providing the actual time and date of the hearing.
