On February 7, 2025, the Defendant's Application for review of sentence was scheduled to be heard by the Sentence Review Division of the Montana Supreme Court (hereafter "the Division") by Zoom videoconference. The Defendant appeared from the Crossroads Correctional Center and was represented by Rufus Peace, Defense Counsel. The State was not represented.

At the outset of the hearing, Defense Counsel informed the Division that the Defendant wishes to continue his sentence review hearing to file a Petition for Post Conviction Relief. The Defendant verbally verified his wish to pursue a Post Conviction Relief.

IT IS ORDERED that the Defendant's sentence review hearing is **CONTINUED** to the next available hearings on May 1 -2, 2025. If the Petition for Post Conviction is not filed prior to the next round of hearings, the sentence review hearing will proceed, or the Defendant will waive his right to review of his sentence as the hearing has been continued a couple times to allow the Defendant time to pursue appellate avenues regarding this matter. Notification will be sent to interested parties at least thirty (30) days prior providing the actual time and date of the hearing.
