On February 6, 2025, the Defendant appeared before the Sentence Review Division of the Montana Supreme Court at the time set for a hearing to review his sentence. The Defendant appeared by video from the Yellowstone County Detention Facility and was represented by Tyler Duggar, who appeared by video from Billings, Montana. The State was not represented.

At the outset of the hearing, Defense Counsel made an oral motion to vacate the Sentence Review hearing and dismiss with prejudice the Defendant's Application for Review of Sentence. The Defendant verbally verified his desire to waive his right to sentence review.


