# Best Practice Guide for License Plate Surrender – Request to Suspend

The purpose of this guide is to demonstrate the use of the License Plate Surrender – Request to Suspend form.

## **Description of the form**

The purpose of the form is to notify the defendant and the Motor Vehicle Division that conviction(s) for failure to comply with the requirements for mandatory motor vehicle liability insurance result in suspension of vehicle license plates and registration and/or the convicted person's driver license. The form also provides the convicted person with instructions for reinstatement after suspension.

## When to use the form

To suspend registration and license plates after conviction, the court must submit the License Plate Surrender – Request to Suspend Form. It is to be submitted manually in conjunction with a conviction for MCA 61-6-301 and/or 302.

- When you mail the weekly MVD report, place the completed form in the envelope with the report.
- If you are electronically reporting to MVD, you may fax or mail the form to MVD on the day that it was created, or as soon as possible thereafter. If your court has a scanner, you may email the form. Instructions to email the form are included in this guide.

# Signed Forms and Unsigned Forms

It is the intention that in most cases, the form is signed by the defendant as acknowledgement of receipt and notice of suspension. MVD states that signed forms will be processed as soon as possible.

MVD further makes the following statement about unsigned forms:

"The Motor Vehicle Division will not suspend upon court submission of an unsigned form unless the Division can confirm (via the form or via associated system checks) that:

- The defendant is the registered owner of the vehicle;
- The form notes that the defendant is an immediate family member of the registered owner or is otherwise authorized by the registered owner;
- The defendant and the registered owner share the same last name;
- The defendant and the registered owner share the same physical address;
- The Division is able to verify that the vehicle was not insured at the time of the offense."

The document will be created automatically. Check the appropriate boxes:

- for 90 or 180 day minimum suspension;
- for driver license suspension if fourth or subsequent conviction;
- Especially if not being signed, check the appropriate box to indicate to MVD that the defendant is the registered owner, an immediate family member of the owner, or that the registration suspension is authorized by the registered owner.

### Courts without scanners: image the document now, as follows.

\*\*SAVE the document at this time. You can use the save icon.

Next, click on the **Image** button in the Image toolbar.

Answer **Yes** to index the image to the case and **OK** to the message that the document was successfully indexed.



#### Print the report and obtain the necessary signatures, with dates.

Close the FullCourt Imaging window and the case document window. Optional: you may choose to store the imaged document ID with the ROA. See the section below starting on page 10.

#### **Courts without scanners:**

Send the form to Motor Vehicle Division at fax 406-444-1631 or mail to MVD, POB 201430, Helena, MT 59620-1430. You may place the form in the same envelope as the manual MVD report with the conviction.

**Courts with scanners** may choose to scan the completed, signed form back to the case and email it.

After printing the form and obtaining the signatures and dates, scan the License Plate Surrender Request to Suspend form back to the case, using the following steps.

Select the Scan option from the Imaging Menu:



It might take just a minute for the Scan window to appear.

**1.** Scan: place the document in the scanner with the printed side down and with the top of the document feeding first. Push the scan icon:



It might take just a minute for the scanner to start feeding the page.

→ 2. Save: once all of the pages are scanned, push the save icon.

→ 3. Index: Click on the Index tab. Indexing consists of three important steps –

→ Give your document a title. For example, "License Plate Surrender."

- → Select the PLTSUSP ROA. There may be more than one ROA available, so make sure that you have selected the correct ROA. The selected one has the pointing finger and is highlighted in bold.
- → SAVE. You will get a message indicating that you have indexed the document successfully. The document ID is stored with the ROA and is visible from the Register page.

Locate and select the image titled License Plate Surrender Request to Suspend (or whatever title you gave if you have scanned the signed image). Observe that there is a Document ID associated with the image. See the example on the next page.

Emailing the form is recommended because it is secure and quick.

To email the form, open the Images window from the main case screen. Highlight the new document and click on the Send Email button.
