**ORDER AMENDING AND ADOPTING MASTER'S REPORT**

Pursuant to Montana Code Annotated, § 85-2-233(5), the above entitled case was assigned to Water Master Julia Nordlund. The Water Master filed a report containing Findings of Fact and Conclusions of Law with the Clerk of Court. Copies of the report were served upon the parties on May 8, 2020. Claimant CB Ranch filed an Objection to Correct the Master's Report on May 12, 2020. The comments pointed out the following typographical errors:

Paragraph 16: The wrong water right number is listed. The correct claim number is 76H 125053-00

Claim 76H 9750-00: Point of diversion IDs 3-8 should not have a ditch name listed as those points of diversion are direct from source.

The Court has reviewed the Water Master's Findings and Conclusions. Pursuant to Rule 53(e), Montana Rules of Civil Procedure, the Court **ADOPTS** the May 8, 2020 Master's Report with the corrections listed above, and

ORDERS that **Post Decree Abstract of Water Right Claim 76H 9750-00** be served with this Order to confirm that the recommendations set forth in the Master's Report, as amended by this Order, have been adopted.
