More specific implementation timeframes will be forthcoming as the OCA staff become adept in the use of the data conversion utility provided by Justice Systems, Inc.

Progress, Progress, Progress

While the Montana FullCourt Enterprise (FCE) project has experienced delays throughout the last several years, progress is being made. We currently have 5 courts installed with FCE; 3 District Courts and 2 Courts of Limited Jurisdiction. We have finally received the long-awaited data conversion utility which will allow us to convert each court within our own staffing resources, no longer bound by JSI's schedule. The data conversion proved to be quite complex even for JSI and is presenting added



challenges for the OCA staff but again, progress is being made. We are striving to complete the next implementation in May 2019, barring any major obstacles in the conversion learning process.

The implementation sequence will attempt to install Automation Committee Member courts first, then large volume

judicial districts, and finally circle back to complete judicial district by judicial district.

The sequence identified below is very tentative and subject to change. We have 192 courts to implement within limited staffing, but our primary goal and focus is the full statewide implementation of FCE.
