INSTRUCTIONS FOR COMPLETING A PETITION FOR HABEAS CORPUS FORM

A Petition for Habeas Corpus tells the Court <u>you are being incarcerated illegally</u> or you <u>will be</u> incarcerated illegally.

- 1. You must put your name on the first line. Put the name under which you were convicted.
- 2. Put your inmate ID or AO number on the second line.
- 3. You must be presently incarcerated in a correctional facility to be eligible for habeas relief so on the third line, put the name of the facility where you are presently incarcerated.
- 4. On the fourth and fifth lines put the address for the facility where you are presently incarcerated.
- 5. Do not put anything below the name of the court. The court will fill in the case number for you.
- 6. In the box---on the top left-hand side put your name.
- 7. In the box—on the bottom of the left-hand side, put your facility's warden or Captain's name; For example: if you are at Montana State Prison, you must put Warden Mahoney's name here even if you are alleging the parole board is illegally denying you parole; If you are in Shelby at CCC, you put Warden Law's name here; if you are in Montana Women's Prison, put Warden Jo Acton's name in this space.
- 8. Do not put anything on the right-hand side of the box.
- 9. Next, answer the questions about your present incarceration.
