
JUDICIAL NOMINATION COMMISSION
Meeting Minutes
Friday, August 28, 2020
Law and Justice Center
Bozeman, Montana

The Honorable John C. Brown, Chair, called the Judicial Nomination Commission to order at 10:10 a.m. on Friday, August 28, 2020, in the district court courtroom, Department #3 in the Law and Justice Center, 615 So. 16th Avenue in Bozeman, Montana. Commissioners Janice Bishop, Karl Englund, Elizabeth Halverson, Hal Harper, and Lane Larson appeared in person; Commissioner Nancy Zadick participated through videoconferencing. Lois Menzies, Office of Court Administrator, attended in person to provide staff services. The purpose of the meeting was to nominate applicants to fill an upcoming judicial vacancy in the 18th Judicial District (Gallatin County).

Applicant interviews were scheduled as follows:

Judge Brown provided an overview of the judicial nomination process. Questions from the Commission followed. Topics addressed during applicant interviews included challenges facing the 18th Judicial District; the impact of population growth on the district's caseload; management of the court's civil docket; views on separation of church and state; plans for running an effective campaign if appointed; bringing biases to the bench and controlling for those biases; setting dates certain for trials; addressing weaknesses in experience; ability to render criminal sentences; knowledge of water law;

methodologies that might be used to address capacity issues; responding to a political party endorsement; addressing partisan politics in a judicial campaign; changing relationships resulting from appointment as a judge; balancing precedent and necessary flexibility in the law; and qualities and characteristics of a good judge. Applicants made closing statements at the end of their interviews.

The Commission began deliberations following the last interview. The concurrence of at least four Commissioners is needed to nominate an applicant for the Governor's consideration. The Commission decided as follows:

- Andrew Breuner was nominated by one commissioner (Brown).
- Audrey Cromwell was nominated by all seven Commissioners (Brown, Bishop, Englund, Halverson, Harper, Larson, and Zadick). Her name will be forwarded to the Governor.
- Eric Kitzmiller was nominated by four Commissioners (Brown, Englund, Harper, and Zadick). His name will be forwarded to the Governor.
- Peter Ohman was nominated by all seven Commissioners (Brown, Bishop, Englund, Halverson, Harper, Larson, and Zadick). His name will be forwarded to the Governor.
- Sheryl Wambsgans was nominated by three Commissioners (Brown, Bishop, and Larson).

The reasons for nominating Ms. Cromwell, Mr. Kitzmiller, and Mr. Ohman are contained in the certificate and report submitted to the Governor, which are incorporated into these minutes and attached to them.

The Commission adjourned at 2:10 p.m.

5. has significant support within the community for serving in the position of district court judge.



5. has significant support within the community for serving in the position of district court judge.


