I urge you to nominate Peter Ohman for appointment as the District Court Judge filling the vacancy created by the retiring Honorable Holly Brown.

Listening and, more importantly, hearing the views of others are foremost among Peter's skills. He has seen and represented juveniles and adults in or from undesirable circumstances who lack social skills or don't seem to conform to societal expectations well. He knows the law and will learn its nuances in application to the facts in cases before him. He has practiced the rules of evidence and procedure in courtroom jury trials and knows their application in cases. Parties and lawyers can be confident they will be treated with respect and their cases will be heard and handled in accordance with the rules, evidence, and applicable law without prejudgement or bias. Peter manages his time wisely. Clerks under his guidance likewise will courteously be helpful in managing his calendar efficiently within the budget.

I've known Peter since I began serving on the Public Defender Commission in 2009. Peter stood out among others in the managerial positions by his quiet, attentive demeanor. He listened. He often spoke last. When he did, everyone listened, often nodding agreement.

As time passed as Chair of the Commission I came to know Peter better, often by pouring over multiple reports generated about how the eleven regions across Montana were doing in terms of cases opened, how long the cases were open, cases closed, the kinds of cases, to some extent the outcomes and, of course, the costs and how the money was spent. My name is Harry Freebourn and I am the former, now retired, Executive Director of Montana's Office of the State Public Defender (OPD). I urge you to send Peter Ohman's name to the Governor as one of your nominees for the open position of District Court Judge for the Eighteenth Judicial District.

I first met Peter in 2006. Peter was an applicant for a major management position with OPD and I was on the hiring committee. OPD is a state agency that provides legal services to individuals charged with a crime in criminal cases and certain civil cases. This agency operates in every district court, court of limited jurisdiction, and in other specialty courts in the state of Montana. I was very impressed by Peter's education, experiences, his composure, temperament, and demeanor during his interview. Gallatin County is fortunate to have so many qualified applicants to replace the Honorable Holly Brown as District Court Judge. Your task, of recommending several lawyers from these applicants to the Honorable Steve Bullock, will be difficult. However, in my judgment, having practiced in this county for 30 years, two (2) applicants, stand out from the rest of the field and are deserving of your recommendation: Peter Ohman and Eric Kitzmiller. Either would be an excellent judge for this District.

1. <u>Peter Bengt Ohman</u>

I've known and worked with Peter for many years in his capacity as the Chief Public Defender for Gallatin County, both as a practicing attorney and when I was a member of the Montana Public Defender Commission.

Peter is passionate about individual rights and protection of those rights. He and I worked together in defending two (2) individuals in a case where the Supreme Court reconciled prior conflicting opinions and held that under Montana's constitution law enforcement must seek and obtain a search warrant

before sending undercover informants into the home of a suspect to record that conversation for use as evidence. *See, State v. Goetz*, 2008 MT 296, 345 Mont. 421, 191 P.3d 489.

Peter regularly appeared before the Montana Public Defender Commission, where I was a member for several years. In that capacity, he argued for the employees under his supervision, as well as others in districts located in Montana, not just his own. Peter was always well-prepared, knowledgeable and provided invaluable insight into the day-to-day issues confronting public defenders. His testimony helped me, and I know other members of the Commission, in making decisions that we believed were in the best interest of all members of the public defender system and their clients.

I have gotten to know Peter better in my current position as an Assistant Public Defender. Although Peter specializes in criminal defense, I believe that Peter he would be both fair and impartial as a judge. The depth of his experience, both administratively and practically, gives him a specialized understanding of how to efficiently oversee the judicial process. Additionally, Peter's even and calm temperament would be an excellent fit for the judiciary. I believe both Peter's personal traits and his professional experiences would be great assets to the 18 Judicial District should the Commission nominate him to fill the vacancy.

To the members of the Judicial Nomination Commission:

We are lucky in this district to have nothing but well qualified candidates whose applications are unlikely to generate any negative comment upon their integrity or competence. I have had the opportunity to practice with or in front of almost all of the candidates and have at least observed them all firsthand in litigation or had personal conversations with them about specific cases and general legal issues. So, I am not surprised to see that they all have friends and family who write in support because they love them, or colleagues and clients who write in support because they respect them.

But these expressions of love and respect do not necessarily provide the Commission with the information necessary to make such a difficult decision. I write in support of Peter Ohman because his depth and breadth of legal expertise, his humility balanced with decisiveness, his mentorship, his administrative skills, and his ability to nurture innovation all help him rise above even this admirable field of candidates.

Basis of my opinion

I am familiar with Peter having worked at the OPD for a little over six years. I began practicing in Helena, where I first became familiar with Peter by name. As a new attorney in an office with high turnover, I ended up with cases ranging from felonies, to juvenile delinquency petitions, to child welfare cases, so I had frequent occasion to reach out for guidance. Peter's name was frequently suggested throughout the state as a person with expertise on any number of topics, whether regarding procedural or substantive law, criminal or civil, or just generally how to manage workload and effectively help difficult clients. Then I met him in person when he was the state training coordinator for OPD. His competence and skill in helping attorneys improve their practice was phenomenal, and he seemed to know every attorney at our trainings by name. I have now been practicing in Bozeman for more than three years, during which time Peter became the statewide director of our trial attorney division. Despite supervising what is likely the largest law firm in the state, Peter still makes time for personalized discussion and mentorship and creates new rewarding challenges for attorneys that continue to foster fulfilment, wellness and practice improvement.

During the three years in Bozeman, I have also gotten to know several of the candidates fairly well, and deeply respect all of them. Mr. Breuner is a fantastic judge and attorney who runs a very fair and efficient court. Mr. Kitzmiller is a highly experienced litigator who advocates strongly but fairly, diligently remembering that his job is to seek justice rather than revenge. Ms. Wambsgans is a former public defender and zealous advocate for her clients. I have seen Ms. Cromwell in action when she guided a legal intern into making a highly impressive, and ultimately successful, argument in defending MSU students through a legal dispute with the city of Bozeman. But even with my respect and admiration for every candidate, for the following reasons I still strongly believe that Peter is the best candidate for the bench.

Expertise

Peter can immediately hit the ground running on any case over which he would preside. His experience with criminal law is obvious, given his nearly two decades of service with the OPD. But as a public defender he handled many types of civil cases as well, from involuntary commitments, juvenile petitions, guardianships, and child welfare cases. Outside the OPD, he has practiced in even broader civil contexts, including as a solo practitioner, as a civil legal aid attorney, and with the Department of Commerce. There is not a case that would hit the bench for which Peter is not already prepared.

Humility and Decisiveness

It seems that perhaps the most vital balance of characteristics for an outstanding judge is a humility to be able to listen and learn and to keep an open mind on every case. On the other hand, justice delayed is often justice denied, and such humility cannot hamper the ability to act decisively. Peter demonstrates this balance on a daily basis in his current administrative role. He must demand and enforce high standards of OPD attorneys while minimizing burnout and turnover. He must make difficult decisions in allocating always limited resources. He must maintain and develop the OPD workforce while also diligently observing his fiscal responsibilities to the taxpayers of Montana. He does so by acting with humility by encouraging healthy debate and actually listening. But he does not delay in making clear decisions, even when there is no easy answer.

Peter also displayed this balance on a daily basis as a line attorney and mentor. It is of course not uncommon for public defenders under stress to give in to the temptation to complain about particularly difficult clients, judicial decisions with which we disagree, or prosecutors' decisions that seem contrary to justice. He never fosters such reactions, but instead encourages approaching issues with humility and empathy. Why is a client lashing out? What are the counterarguments that swayed a judge against your point, and how can you better address those next time? What is the prosecutor trying to accomplish, and why did they believe their actions would achieve that goal?

Peter has the humility to faithfully follow the law, to keep his mind open in each particular case, to seriously consider any challenge to his opinions, and to promulgate clear decisions that will bring just resolutions to any case on his docket.

Mentorship, Administration and Innovation

The members of the Eighteenth Judicial District bench and bar and the public they serve struggle with exploding case numbers, only three district court judges to handle them all, and cramped facilities. Peter is in a unique position to cope with this situation, having served as an administrator, first in this district then for the entire state.

Innovation is, unfairly, not often associated with public servants. But in truth Peter has shown extraordinary innovative skills in guiding a large public agency through a period of institutional maturation, as the OPD is now only roughly fourteen years old. In that time, caseloads have exploded as the Legislature relies upon criminalization to confront social concerns, as law enforcement agencies increase their numbers and arrests, and as the population of the state increases (most rapidly in this district). And now this is all occurring in the context of the COVID-19 pandemic. In the face of these challenges, and throughout this time of agency growth, Peter has demonstrated his excellent work and innovation by being promoted first to a regional and then statewide administrator. He has fostered a culture of great cooperation. He has mentored a number of outstanding attorneys in a way that has improved legal practice not just in the OPD, but in all the other public agencies, private firms, courts and solo practices where attorneys and staff who learned from Peter now work.

Improvements in child welfare practice are just one concrete example of Peter's abilities in this area. Child welfare cases are perhaps the largest area of growth for the OPD in terms of case numbers and consumption of human and monetary resources. Peter has worked with members of the judiciary, consulted with legislators, and delegated to other people in the OPD in order to provide necessary information on legislative solutions, to improve the advocacy of our attorneys, and has identified and secured sources of federal funding. He has managed to

cooperatively innovate in a cost-effective manner that ultimately improves the lives of Montana children and their families.

This is exactly the kind of skill that is so needed in this district at this time. Peter has a proven track record in the area that no other candidate has. Clerks and staff that work for him, and the attorneys that practice in front of him, will be better practitioners. Most importantly, all people personally affected by the cases he will decide will all benefit from his innovative and cooperative approach to legal and administrative problem solving.

Conclusion

Peter's lifelong public service proves that his application is untainted by personal ambition. In his conversations with friends and family about whether to throw his hat in the ring for the bench, his questions or comments are not about whether serving on the bench would be a good move for him personally, but rather whether this is the best way for him to continue to serve the people of Gallatin County and the State of Montana. His decisions will be guided solely by what the law requires and what is just and equitable. The attorneys who practice in front of him will be treated with respect and leave better advocates. He will bring an innovative and collaborative approach that will best serve the people of Gallatin County, even when compared to the other eminent candidates.
