I am writing in support of Sheryl Wambsgans' candidacy for appointment to the position of district court judge for the 18th Judicial District.

I know Sheryl well. We met approximately 10 years ago, shortly after I relocated to Bozeman from Philadelphia where I was a Managing Director with Morgan Stanley Investment Management. Subsequently, my wife and I have spent significant time with Sheryl (and her husband Chase) on a social basis and consider them close friends. I have also worked with Sheryl professionally, using her on a number of personal legal matters. Having worked with many lawyers during my career at Morgan Stanley, I can say her legal abilities are strong.

Since the majority of my time spent with Sheryl has been on a social basis, I will limit my comments to the personal characteristics I have observed that I believe will make her an excellent judge. These comments are based not only by my direct interactions with Sheryl over the past 10 years, but by my experience running a significant investment organization (Morgan Stanley Alternative Investment Partners) with over 100 (mostly) professional employees for a decade. During my time at Morgan Stanley I had the opportunity to hire and manage dozens of professional employees, which allowed me to gain insights into qualities displayed by high performing individuals. I believe Sheryl embodies many of these characteristics, some of which I have outlined below (in no particular order):

• Intelligence

- Sheryl is simply very smart.
- The basis for making this judgment is mostly my time spent in college and my career where I was surrounded by a lot of smart people. First, my undergraduate Chemical Engineering classmates at Montana State. Second, involvement with same at the Wharton Business School. Third, at Morgan Stanley where most of the investment people were top performers in both their academic backgrounds (mostly from top undergraduate and graduate schools), and in their careers.
- Judgement
 - I have had numerous opportunities to observe Sheryl's judgement and decision making skills during the time I have known her. She is an active listener, considers all available information in a balanced, objective manner, and then makes a timely decision.
 - What I have never seen Sheryl do is make decisions based on emotion and limited facts and data which is another sign of good judgement.
- Strong work ethic

- During the time I have known Sheryl she has always had a full time job in the legal profession. First, in the Bozeman Public Defenders office followed by stint in a private practice, and finally establishing her own practice a few years ago. All of these "regular" jobs included long working hours.
- On top of her regular full-time jobs, Sheryl always had a second part-time job. I believe this started out as a way to accelerate payments on her school loans, but has continued subsequent to paying those off.

• High emotional intelligence

- In my experience, the concept of emotional intelligence (i.e. in its essence the ability to communicate and interact constructively and effectively with a broad range of people and personalities) is an important driver in the success of people in job's where "people skills" are important. Although my experience in a courtroom setting is limited, I would assume this ability would be important as a judge given all the different types of people a judge deals with both in and out of court, and the high level of emotion involved in many of these interactions.
- Based on my observations of Sheryl dealing with a broad range of people over time, she has a high level of emotional intelligence.

• Unquestioned Integrity and Character

- During my career at Morgan Stanley, the primary job was selecting investment managers to include in client portfolios. A key part of our due diligence was assessing manager integrity given the substantial sums of money these individuals would be investing on behalf of our clients. Assessing integrity is hard, and mostly based on assembling a set of disparate data points over a significant period of time and making a judgement based on experience. I did this for hundreds of managers for well over a decade, mostly and increasingly successfully.
- Based on my 10 years of material interactions with Sheryl, she has high integrity. Not once in my 10 years of interacting with Sheryl has she ever done to cause me to question that view.

This is not an all inclusive list of the factors that I believe will make Sheryl an excellent judge for the 18th Judicial District but rather outlines the most important ones.
