## Dear Judicial Nomination Commission:

I am writing to register my confidence in Daniel M. Guzynski in his application for the 1<sup>st</sup> Judicial District Court (Broadwater and Lewis and Clark counties). The chance to have a candidate of his quality for the 1st Judgeship is an opportunity not to be missed. His significant work in the courtroom requires a solid working knowledge of evidence and procedure which is such a bonus when it comes to taking the bench. Civil matters and written motions allow a judge to educate themselves on their own time in chambers. But the pace of a jury trial requires rapid decisions on objections which can compromise the case and create appellate error. Trial experience in the wide ways a case can go sideways in an instant is critical.

My primary knowledge of Mr. Guzynski is based on the cases he has tried and or handled before me. His cases are complex or political because that is what his office takes when requested by the county attorney. One case upon which I sat was a difficult, long, highly contested case. Pretrial motions included 120 motions or submotions. Dear Judicial Nomination Commissioners:

Recently a victim told me a story about how Dan Guzynski baked her cookies, brought them to a meeting with the defense team, and instead of having a chance to eat the cookies, they watched the defense attorney gobble them all down. This happened a decade ago and despite the horrendous circumstances that brought this victim and Dan together, despite multiple meetings, a trial, and sentencing, this is the memory this victim carries around with her. She, along with the countless other victims Dan has worked with, remember him for his kindness and ability to support them through traumatic, atrocious experiences.

The criminal justice system is an offender centric system that often does not take into account the worries, concerns, and trauma experienced by victims and their families. Dan is the exception in this system. He has left lasting impressions on the hearts of those he has worked with. He has supported and guided people with significant trauma through additional traumatic experiences, through a system that often does not hear their voices. Dan has given victims and families of victim's voices or been their voice in this system.

When I first started with the parole board a little over two years ago, Dan took the time to sit down with me and go over the position and discuss how we could work together. Since that time, I have been fortunate enough to meet with his team at the Prosecutorial Services Bureau and work with him and several others on that team. This collaboration has given victim's voices during parole hearings they may not otherwise have. There have been victims notified that were not registered to be notified. There have been victims supported through the process as Dan and his team sat through parole hearings with them. Dan has gone above and beyond by submitting statements and additional information to the board, enabling them to make the most informed decision. Dan has been a diligent support for victims and their families by sitting and supporting them during parole hearings as they are faced with a trauma similar to testifying at trial or during sentencing. Parole hearings are like ripping open old wounds and setting up victims for a complete change in their lives. Dan and I have talked extensively about this process and the trauma it can cause and the best way we can work together to support the victims of Montana through such a trying time.

I first met Dan in the summer of 2001 when he was a Deputy Flathead County Attorney and I was clerking with the Flathead County Justice Court in Kalispell. Our friendship has continued over the past 19 years, during which Dan joined the Attorney General Office's Prosecution Services Bureau and I began clerking with the Montana Supreme Court here in Helena.

Upon meeting Dan, I immediately was struck by his passion for the law, his respect for the courts, and his commitment to justice. I have observed these qualities in Dan consistently over the years I have known him. In my opinion, Dan exemplifies the sort of prosecutor that the United States Supreme Court described in the off-cited Berger case: "He may prosecute with earnestness and vigor-indeed, he should do so. But, while he may strike hard blows, he is not at liberty to strike foul ones. It is as much his duty to refrain from improper methods calculated to produce a wrongful conviction as it is to use every legitimate means to bring about a just one." Consistent with this principle, Dan's goal has never been about simply tallying up convictions at any cost. Rather, it has been about fairness and justice for all involved—the victim, the community, and the accused. Indeed, I have known Dan, when prosecuting a case, to remain respectful and cognizant of the constitutional rights of the accused. One example of this occurred several years ago when Dan (rather than defense counsel) noted the defendant's absence from an in-chambers discussion and promptly asked that the defendant be brought to chambers before the discussion continued. This is but one example illustrating Dan's commitment to fairness in our legal system, a quality I believe is essential in any good judge.

Dan is quite knowledgeable in multiple areas of law—as I am sure other candidates are as well. But every judge is eventually faced with legal issues with which they have not had previous experience, and what has particularly impressed me about Dan is the determination with which he confronts such issues. Dan and I have discussed the ins and outs of various legal questions over the years—both criminal and civil—and he has never been one to throw up his hands or take the easy way out. Quite the contrary, Dan works through each problem until he has gained a good understanding of the issue, the law, and the correct resolution. I can attribute much of my own knowledge of the law to these discussions. During my nine and a half years clerking with the Montana Supreme Court, I read numerous District Court orders and decisions—some that reflected a great deal of thought and research, and others that did not. I sincerely believe that Dan's orders and decisions would fall in the first category:

reflecting an understanding of the issues, comprehension of the law, and a reasoned judgment. I believe this is another quality that is essential in any good judge.

Finally, I would like to emphasize that Dan is one of the most competent, ethical, fair, and even-tempered persons I know. He is extremely conscientious, attentive to detail, and a capable decision-maker. He treats his family, his friends, his coworkers, and the various individuals he interacts with in the legal system with the utmost respect. These qualities, combined with his commitment to justice and the law, would inspire confidence in our legal system among those who appeared before him—litigants, attorneys, and members of our community.

I believe Dan would make an outstanding judge, and I strongly urge you to forward Dan's name to Governor Bullock for his consideration.

Ladies and Gentlemen,

For those of you who don't know me, I am the District Judge for the district in far northeast Montana. I have no horse in this race, but I feel I should take this opportunity to comment on one of the applicants, Dan Guzynsky.

I am acquainted with Dan because he has prosecuted a number of difficult, high profile, criminal cases through multi-day trials in front of me in several counties over the years.

My observation is Dan has the personality that would make a fine Judge. He appeared concerned with the truth, fairness and patiently treating people with respect while still following the law. Dan is not one of those lawyers who will stretch the law or facts to win no matter what.

Managing trials where Dan was the prosecutor was easy. Dan was always doing the right thing and I did not have to be vigilant watching for unfair activities the defense attorney might miss, nor did I have to worry about dealing with a potential mistrial from counsel going over the line. Dan was prepared, quiet, patient, meticulously following the spirit and letter of the rules, and always treating people, even defendants, with kindness and respect.

Being a District Judge is often a lot like babysitting. You have squabbling parties, not following the rules, not waiting for their turn, wanting to keep going with the fight to win no matter what, and pouting when they don't get their way. I believe Dan will be able to sort the wheat from the chaff, to efficiently sort out the mess, to get to the right result while following the rules, and to leave the parties feeling, even when they are unhappy with the ruling, that they were treated fairly and the result is also fair.

For Judges and attorneys, litigation is an everyday thing. It takes more than a sharp technical legal mind to be a good judge. The difficulty is making sure people who are not regulars in the system feel they were treated fairly and the law was followed. Conducting the proceedings so you leave people feeling

they were treated fairly, despite the antics of the lawyers, is often difficult and sometimes impossible. My observations lead me to believe Dan will be good at doing that.

I have done this "District Judge" thing for almost 26 years. Because of conflicts and the substitution rule, I have had lots of cases in lots of counties after a new judge was appointed or elected. Consequently, I have seen a lot of new judges in action. In my opinion, and for what it is worth, Dan Guzynski is the type of person who will do well.
