


Dear Judicial Nomination Commission:



I am now retired, but for 25 years I worked for the federal district court in Helena, and I would estimate that I observed Mr. Hoovestall's work in the courtroom in at least 200 proceedings. What I have observed is that Mr. Hoovestall is a dignified, serious, and hard-working attorney. I never knew him to be unprepared for court or to miss a deadline. Not only is Mr. Hoovestall a talented trial attorney, he is a reliable professional. His courtroom demeanor is respectful and pleasant to all, but I never doubted that furthering his client's interest was his central purpose.
