These attributes make it likely the proceeding and decision making will be viewed as above board and free of arbitrary or capricious conclusions. In this morning's paper, September 23, 2020 edition of the Helena Independent Record, there was an article under "Health Matters" written by Dr. Kyle Moore, addiction specialist at St. Peter's Health. In his article, Dr. Moore explains how addiction is a disease, and that it's treatable. I think it's important for a judge to understand the medical and health aspects of addiction. Having had numerous conversations with David on this topic, it's clear to me that he understands this and the risks to individual health and societal well-being that drugs pose.

I am aware that David is a coach for the mock trial competition teams at Helena High School, and did a terrific job relating to the students in Kacey Askin's Law and Justice Class.

I believe David Morine is not only exceptionally qualified for the judgeship position, but he is also a kind, compassionate, and fair human being who believes in second chances.

Dear Ms. Menzies,

Please accept this letter as my recommendation supporting David Morine's application for appointment to replace Judge James Reynolds in the First Judicial District. I wholeheartedly support David in his effort to be appointed.

I became professionally acquainted with David around March, 2019. My firm represented Melissa Dyekman in a wrongful death lawsuit relating to the death of her husband, Jeffrey Dyekman. Jeff was a long time employee of the Montana Department of Transportation and was killed when a young man drove into a marked construction zone on I-90 in Billings, striking and killing Jeff. Two of Jeff's co-workers were standing by the accident and also sustained injuries. The trauma and damages sustained by our client and her two children were significant.

David and his partners, Tom Hattersley and Teri Walter, defended the driver who struck and killed Jeff. Their client's name was Ethan Anderson. He was an employee of a company in Billings named Big Sky Steel & Salvage, Inc. The carrier involved had hired David's firm to represent Ethan separately from the company as it was discovered that Ethan was under the influence of difluroethane (DFE) at the time of the wreck, which ultimately led to serious felony charges against Mr. Anderson. DFE is found in inhalants, such as dust-off spray for computer keyboards. It causes significant impairment when inhaled.

David was highly involved in the case from the beginning to its conclusion. During our work on the case, I learned quite a bit about David. First and foremost, he was incredibly professional, diligent, responsive, and pleasant to work with. He defended his client well considering the significant consequences that arose from the incident, both civilly and criminally. David was cooperative in making arrangements for us to depose his client at the Montana State Prison,

including making recommendations as to pre-approved court reporters and tips on scheduling the deposition (it proved to be cumbersome). Even though our case involved facts which pointed squarely at his client's liability, David never lost sight of his responsibility to ethically and zealously defend his client, even under difficult circumstances. I know he spent a significant amount of time explaining the status of the civil action to his client, including making time to visit him in person while he was incarcerated. I also note that he was kind and respectful to his client, despite the bad decision his client had made which ultimately led to Jeff Dyekman's death.

At the same time, he expressed genuine empathy for the loss occasioned on our client and her teenage children. He was concerned about them and about the pain they were experiencing. In working to resolve the Dyekman case, I spent a great deal of time talking to David and his partner Tom Hattersley and never felt like I needed to look over my shoulder or that I was at risk of being hood winked. In fact, we spent a lot of time discussing various legal issues that may arise because of the wreck, including exclusions to insurance coverage, possible claims relating to scope and course of employment, and affirmative defenses such as intervening and superseding cause. I was not concerned that my transparency with David would cause my client's case any harm; quite the opposite, as David too was forthcoming with his evaluation of the case.

Luckily, I was able to spend some time visiting with David during depositions and mediation, including a long lunch in Billings. As a "person", he is affable, smart and down to earth. He has a broad background in civil litigation, which was obvious in working with him and I hope weighs heavily in the commission's evaluation of his credentials. He is compassionate and diligent. I wholeheartedly support David's application to be appointed to the bench in the 1st Judicial District.
