Dear Ladies and Gentlemen of the Commission:

I write to offer my *wholehearted* support for Standing Master Grubich's application for the District Court Judge position in the Eighth Judicial District, Cascade County.

I have known Dave since shortly after he arrived in town. Our first significant contact, as I recall, was when I served with him on the Board of Directors of the Cascade County Law Clinic in 2012. He immediately struck me as earnest, honest, and hard-working. Of course, these are all traits required of a judge.

I have considered him a friend since that time. I will not suggest that we socialize frequently, but we have on a few occasions. We do not always agree politically, but we have always been able to discuss things in a calm polite fashion, and he can use his disarming smile to great effect.

To Whom It May Concern:

I am writing to recommend the appointment of either Steve Bolstad or David Grubich to the Eighth Judicial District Judge seat. I believe that these two candidates, among the several who have applied, are head and shoulders more qualified than the rest. Either would be an excellent choice to fill the vacancy, and urge you to select from the two of them. In my opinion, what sets these two candidates apart is their commitment to public service, their breadth of life and legal experience, and their compassionate nature.

I know and respect several of the other applicants, but do not believe they possess the same qualifications. Quite candidly, as a left-leaning, outspoken progressive woman, I'd love to be able to write on behalf of a female candidate. However, I do not believe this commission should elevate gender politics over the inherent qualifications.

Judge Steven Bolstad

I have known Steve for approximately 23 years. We first met in the Fall of 1997 as first-year law students at the University of Montana School of Law. Steve and I both eventually ended up practicing law in Great Falls, Montana. Steve worked as a County Attorney, and later (currently) as our Municipal Court Judge. As such, I have worked both across from and in front of him. I believe Steve has a firm grasp on Constitutional issues specifically affecting criminal law, and treats litigants with respect and fairness. While I do not always agree with his rulings (as I am a criminal defense attorney), I have always felt like he has considered the arguments I have advanced and given both sides a fair shake. I know that Steve is community-oriented: he unsuccessfully lobbied for years for me to join a civic service organization of which he was a part. You can tell a lot about Judge Bolstad's character because his staff seems to really like and respect him.

Prior to entering law school, I learned from social conversations with Judge Bolstad that he had worked, among other things, as a public school teacher. He was extremely proud of the fact that he made his students memorize the County Seat of each Montana County. Steve is a proud (almost) lifetime Montana resident, and just a good and honest human being. I considered him among my group of friends in law school (although I did not attend Griz games with him, for the

record). Reading through his application, I wholeheartedly agree with his assessment about his integrity being important: several years ago, Steve took me to task when he disagreed with language I had used in the conclusion section of a brief which criticized the State's actions. My mother, also a public school teacher, freely used words like "asinine" and, as a young attorney, I never realized the inflammatory nature of the word. Steve made sure that I did. However, we were able to mend fences fairly quickly and successfully resolve the case (which involved over 200 misdemeanor counts) without the need for trial.

Judge David Grubich

Our Standing Master, Judge Grubich, would also make an excellent judge. Prior to obtaining the Standing Master position, I knew Dave primarily through service on the Board of Directors of the Cascade County Law Clinic. (We specialized in different areas of law, so I never had an opportunity to evaluate him as a practitioner. However, the Judge's reputation among the members of the Bar was impeccable. I've never heard anyone relate an instance of Dave being disrespectful or losing his temper with other members of the bar or litigants.) Judge Grubich was very invested in the Board's mission, access to justice, and was not just a passive participant. In reviewing Dave's application, I was struck by the breadth of his life experience, including service to his country and experience as a law-enforcement officer.

I'm always hesitant to recommend former law enforcement officers, or attorneys who only have exposure to civil practice, to the bench because I find that they often bend over backwards to rubber-stamp the State's action, or are hesitant to make any legally correct, albeit unpopular, decision. (For example, years ago, a District Court Judge ruled in my client's favor suppressing a coerced confession, which resulted in the dismissal of a deliberate homicide charge. I've always respected her, a former prosecutor, for that.) I don't have that concern with Judge Grubich; I honestly believe he is fair, and very capable of understanding the sometimes-complex nuances of Constitutional issues. Prior to ascending to the bench, at our annual Cascade County Bar Dinner Dave was always at the forefront of either the comedy (and I use that term loosely) portion or actively soliciting funds for the law clinic through our "raise the gavel" fundraiser.

I've appeared and argued in front of Judge Grubich dozens of times. He's not always ruled in my favor, but I appreciate his thoughtful, conscientious decision making. His even-keel approach is much appreciated in hotly contested, emotional, and sometimes downright nasty custody hearings. I appreciate that he makes timely, decisive rulings and does not make litigants wait weeks for a ruling. Dave is organized, highly intelligent and empathetic.

Thank you for this opportunity to submit a recommendation for these two excellent candidates. Because you have wo extremely qualified individuals, selecting our new Eighth Judicial District Court Judge is task I do not envy.

Humility, intelligence, and compassion are critical in a judge. This is to encourage your serious consideration of the application of Standing Master David Grubich. I have known Mr. Grubich since he was in private practice, working in the law firm of Ugrin, Alexander, Zadick and Higgins. Although we had no cases directly against each other, I always found him to be professional, thoughtful, and courteous. Despite his busy private practice, he also committed himself to ensuring that Montanans living in poverty had access to the courts by performing significant *pro bono* representation. He was then, and is now, well regarded by members of the Cascade County Bar Association.

After I took the bench, our district hired Mr. Grubich as our standing master. The Standing Master in this County traditionally carried responsibility for most, if not all, of the family law cases for the district. To the Judicial Nomination Commission:

My name is Trevor Carlson, and I have been practicing law in Central Montana since 2013. I have a solo practice in Great Falls, Montana, that provides services for criminal defense, family law, landlord-tenant law, and civil litigation. I routinely appear in about a dozen counties around the area.

I have had the pleasure of appearing before Standing Master David J. Grubich since his appointment in August of 2018. In my practice of family law, I have appeared before him on several dissolution and parenting plan proceedings. I have also appeared before him on uncontested adoptions and guardianship/conservatorship proceedings. He has become one of my favorite judges to practice in front of, and I trust he would make an excellent District Court Judge.

I believe that a judge should have three qualities: 1) an ability to accurately and fairly interpret and apply the law; 2) an excellent work ethic; and 3) the proper temperament. Standing Master Grubich has all of these qualities, which is why I am writing this letter in support of his appointment.

In my cases, Standing Master Grubich has issued several orders over the last two years. His decisions have always been well-reasoned and in accordance with Montana statutes and case law. In trial, his rulings on evidentiary issues have been similarly sound. While I have not always agreed with his rulings, I cannot say that they were wrong, and I have never felt a strong urge to seek an appeal after my cases have concluded before him.

I appreciate this adherence to black-letter law, as it brings predictability to the bench and helps me manage client expectations before going to court. It also saves my clients money by not having to appeal erroneous rulings. In reviewing his application for the Eighth Judicial District Court Judge position, I was not surprised to see he graduated from law school with honors, as he has consistently shown the intellect required for both academic performance and proper interpretation and application of the law.

Both my clients and I are grateful for Standing Master Grubich's work ethic and turnaround time on decisions. It is important for our legal system and society at large for citizens to feel they have been treated fairly and afforded their "day in court," or what we lawyers call "due process." It is not easy to explain to your clients – many of whom have little or no experience with the legal system – why a judge will "only" afford them a few hours for issues so near and dear to their hearts such as parenting time or property distribution. These are issues that will affect the client and those they love for years to come, and it is important for the integrity of our legal system that litigants feel their cases were afforded a proportionate consideration for what is at stake.

Standing Master Grubich has always accommodated my clients' requests for lengthy hearings, and in cases that unexpectedly exceeded their allotment, he has patiently allowed the parties to present their full witness testimony, evidence and arguments. He has always been attentive and interested in each piece of testimony and evidence presented. I can recall a recent hearing that ran until 6:00 p.m. Both my client and I were grateful to have the time to present our case properly and fully to the Court.

When it comes to issuing written decisions, Standing Master Grubich has a very swift turnaround time. I know that it is not easy condensing hours of testimony into findings of fact and conclusions of law on top of an already full trial caseload. I have never asked him directly, but I suspect that Standing Master Grubich probably works nights and weekends to keep up with the litany of contested hearings that a Standing Master is assigned. He does not leave the parties wondering and waiting for the outcomes of their cases (and, in many family law cases, the outcomes of their lives) for weeks or even months on end.

In reading his application for this position, I was once again not surprised that he describes a lengthy history of public service, pro bono work, and a desire to improve the community through the legal system. I can tell you from my own observations that he personifies the devotion to public service that is described in his application.

Finally, it is my opinion that Standing Master Grubich has the proper temperament for a District Court Judge. I have witnessed him deal with unruly litigants, both *pro se* and represented, and at times, unruly attorneys as well. During these incidents, I have never seen him lose his temper. Instead, he maintains his composure in a very professional manner befitting of a judge. His courtroom demeanor is firm, yet equable, and he is a pleasure to practice in front of.

I hope this letter helps you in your decision for the next Eighth Judicial District Court Judge. I strongly believe that Standing Master David J. Grubich would be an excellent addition to the bench here in Cascade County.

Dear Judicial Nomination Commission:

I am writing this letter in support for David Grubich for the 8th Judicial District Court Judge. I also write this letter to inform the Commission that I do not believe Steven Bolstad is the right person for this important job. The Cascade County community has a long history of having independent district court judges that possessed the right temperament, value and integrity so the rule of law was respected in an ever-changing legal environment. David Grubich will be able to continue that legacy.

I had the pleasure to write to this Commission two years ago regarding the Hon. Kaydee Snipes-Ruiz in the 12th Judicial District Court. I currently work at the Montana State Office of Public Defender, Region 3, in Great Falls, Montana as an attorney. I represent clients in felony criminal cases, dependent neglect cases, juvenile and involuntary commitment cases in the 8th Judicial District Court. As a practicing attorney in 8th Judicial District Court, I feel I have an obligation to write this even if it has negative repercussions on my practice because of the importance this position has.

Why in support of David Grubich:

I have had the pleasure of practicing in front of David Grubich in his capacity as the Standing Master for the 8th Judicial District Court. I have always been impressed with Standing Master Grubich's judicial temperament. Standing Master Grubich never gets too high or too low with the parties. He does not let prejudice, passion or anger rule his thought process. Standing Master Grubich takes the facts and the rule of law to decide his decisions. I will admit that the first time practicing in front of Standing Master Grubich during an initial appearance, I was skeptical that his previous experience with law enforcement would slant his thinking and not give my client a fair shake. I found the opposite to be true. I have personally witnessed him treat attorneys on both sides of a case with respect. If he is chosen for the position, I know he would carry that same mentality as a district court judge.

Standing Master Grubich truly understands the Cascade County community. His experience handling family law and dependent neglect cases is going to be a real benefit in those caseloads. As this Commission is probably aware that Cascade County has one of the highest filings per capita of dependent neglect cases in the State of Montana. Those cases typically have families that face systematic barriers to achieve an amicable resolution. Standing Master Grubich is the person that already has a pulse on the hurdles Cascade County families face.

Standing Master Grubich also has the requisite experience to handle the Cascade County civil litigation case load that often gets puts on the back burner. Standing Master Grubich will not ignore these cases and will be able to effectively handle complex civil litigation. His years of experience working at Ugrin, Alexander and Zadick, P.C. gave him a wealth of experience of handling broad array of civil litigation issues. I have the utmost confidence he will be able to handle these types of cases as judge.

The other real benefit to Standing Master Grubich being the district court judge is that he already regularly assists the other district court judges and appears to have a good working relationship with all of them. I believe he will be able to effectively work with the other judges on calendaring, logistical, local rules and other issues that arise when multiple judges are in a district. As a litigator that is often in Court four days a week in all four departments it would be frustrating to me in recent years when the judges would appear to be in squabbles over certain issues. It would negatively affect my legal practice because when the judges would be in disagreement, I would be in a difficult position of either having to be in two places at once or not truly understanding what trial had priority when they both were scheduled for the same day. Standing Master Grubich will collaboratively work with the other district court judges to avoid these issues.

Why not in support of Steven Bolstad:

I will admit I know very little personally of Steven Bolstad. However, I have a lot of reservations about him being able to handle this position if appointed. My experience practicing in Great Falls Municipal Court is fairly limited as I have mostly practiced in District Courts in the Hi-Line and in 8th Judicial Court but I have had plenty of colleagues that have practiced in front of him. I have also appeared for my colleagues in Great Falls Municipal Court a couple of times. My experience in front of Judge Bolstad has been negative.

My impression of Judge Bolstad is that he is a former prosecutor that has carried that over to the bench. He also appears to let passion, prejudice or anger come to his thought process. I do not believe he has the judicial temperament to handle this position. I have had colleagues tell me in recent years how he has threatened contempt or yelled at them in an attempt to bully or embarrass them, as public defenders, from making good faith arguments.

I personally appeared as stand-in counsel not too long ago in Great Falls Municipal Court for initial appearances. There was a female client that had multiple allegations/cases dealing with petty misdemeanor theft. Judge Bolstad decided to set an aggregate bail amount at \$45,000 per prosecutor request. I challenged the Court on that bail. I argued in good faith using the bail factors in MCA § 46-9-301 and set forth an example of the unreasonableness of that bail because at the time I was representing a client on more serious felony allegations in District Court that did not have a bail amount that high. Judge Bolstad preceded to lose his temper, threaten me with contempt and forbid me from speaking further. He then set unreasonable release conditions prohibiting this female from essentially any convenience, retail or grocery store in Great Falls, MT.

I also have regularly had clients that I represent on a felony that will be released on their own recognizance for that case but still will be incarcerated on a Great Falls Municipal misdemeanor case. The reason is because he set an unreasonable bail amount that the client could not afford. It has been on charges as small as disorderly conduct, driving offenses or petty theft. I am very worried what he is going to do with indigent people on more serious allegations if he becomes the District Court Judge.

He also regularly poses with Great Falls Police Officers for photos for the Great Falls Police social media pages. The appearance seems to allude to the fact that he unabashedly leans in that direction. It becomes even more apparent with his writing samples he has provided this Commission. They are all orders denying defendant's motions. Other practitioners in the criminal defense bar have informed me that is par for the course for Judge Bolstad. I believe that calls into question whether he can truly be an independent and fair judge for very serious criminal cases.

Concluding Remarks:

I appreciate the time the Commission took to read my public comment on these two candidates. I truly believe that David Grubich is the right person for appointment as the 8th Judicial District Court Judge.

Now knowing about his law enforcement background, I have a better sense of the discipline and insight I have observed in his handling of cases and client matters, both as an attorney, and then as standing master. His background has obviously helped him develop and hone those skills. They are critical for a judge to possess when he or she begins work *as* a judge; we cannot afford to wait for those skills to show up at some later time.

Finally, as the standing master, Mr. Grubich has worked closely with me the past few months in the development of a new family law program we hope will improve the process of adopting and implementing parenting plans. Although the program was initially developed by Clinic staff and our attorney board members, the refinement of the plan required the careful eye of a judicial officer – in the case, Mr. Grubich. Working with our district judges, he has helped to make the plan more realistic and workable once it is put into practice. I am convinced that, once the plan is underway later this year, Mr. Grubich's work on and support of the plan will be critical to its success. His eye for innovation is a trait we need so desperately in the judiciary.

Standing Master Grubich is well-positioned, both personally and professionally, to assume the responsibilities of a state district court judge, I again recommend him for favorable consideration as a nominee.

Dear Commission Members:

During the last 45 years practicing law in Great Falls, we have had numerous district court judges.¹ Some of these people were well-respected lawyers who had extensive broad-based experience before ascending the bench, while others did not.

What distinguishes the good district court judges was not their broad experience in the practice before ascending the bench. Rather, what distinguishes the good district court judges is how they used the extraordinary power of their offices.

Prior broad professional experience is not in itself a predictor of how one will perform as a district court judge. However, prior experience does give one an indication of how prospective judges will use the power of their offices. But there are other means to determine how one will use the power of their offices. How one treats the service providers in their daily lives can be a good indication of how one will use power. And how prospective judges have used whatever power they have in their jobs often provides a good indication of how they will use judicial power.

None of the people in this applicant pool have prior broad professional experience that will enable one to assess how they will use the power of judicial office in the manner in which it is supposed to be used. Other than the personal recommendations that accompany their applications, we have no idea how they will use their judicial power.

I am acquainted with three applicants who have power and who have used it in a measured, proper way. For this reason, these applicants should have their names passed on to the governor for his consideration.

1) Steve Bolstad presently serves as a city court judge. The people who appear in his courtroom have been charged with engaging in publicly irresponsible behavior. These people are often the weakest and least powerful citizens among us. Yet, Steve treats the people in his courtroom with respect, humanism, and without cynicism. That is a hard thing to do in his job.

2) Michele Levine presently serves on Cascade County's zoning board. Regulatory boards, generally, are apt to be controlled by the interest that the board seeks to regulate. In the case of zoning boards, the real estate and development industries regularly appear before zoning boards; and as a result, zoning boards typically end up promoting the interests of the real estate and development industries. It is hard for regulators not to align their interests with the interests they are regulating, because the regulated interest constantly appears before the board. Yet, Michele has consistently resisted this pressure while serving on the Cascade County Zoning Board. This is a hard thing to do in this job.

3) **David Grubich** presently serves as the district court special master for family law matters. This job often involves making decisions in contested child custody matters in which neither side or only one side is represented. Decisions that are wrong in this context can have lifelong devastating consequences to the children who are the victims in these broken unions. David recognizes the importance of these decisions. This is a hard thing to do in this job.

I unequivocally endorse Judge David Grubich for appointment to the judicial vacancy In Cascade County and this letter is in support of his appointment.

My name is Donna Gass and I am the office administrator at the Cascade County Law Clinic (CCLC). The CCLC is a small non-profit located in Great Falls, Montana. Our mission is finding pro bono attorneys for low-income individuals in family law and tenant/landlord issues.

My interactions with Judge Grubich include his previous role as board member with the CCLC and as the current Standing Master in Cascade County District Court.

As a board member, I observed Dave's tireless efforts to close the gap in legal services and improve relations between our organizations' various stakeholders.

When Dave became the Standing Master, I continue to observe his legal knowledge, empathy towards pro se litigants and continued efforts to improve the courts.

Family law issues are always acrimonious. Judge Grubich recently presided at a hearing for one of our clients, who had to appear *pro se*. The action is a parenting plan modification, possibly resulting in immediately relocating a child out of state. After the hearing, the client reported the Judge's thoughtfulness towards her son and the law. He declined to issue an Order from the bench, easing all parties concerns for immediate removal of the child. It's obvious Judge Grubich considers the statues and what's in the best interests of an eleven-year-old boy. He clearly considers the commonsense approach to administering that law. Judge Grubich is an outstanding example of what all lay people (non-attorneys) think a good judge should be.

Our clients at CCLC are *pro se* litigants until they are given a pro bono attorney referral. Our clients are extremely fearful and anxious about going to court without legal representation and appearing before a judge. Everyone thinks the judge is going to take their child away, the judge will throw them in jail, or their lack of legal experience will up set the court, affecting the circumstances of their case. After a hearing date, these are some of the unsolicited comments I

have heard about Judge Grubich:

"...fair, kind, understanding, empathetic, and spoke so I could understand what was happening". The clients are pleasantly surprised Judge Grubich was so understanding, nonjudgmental to the circumstances of the case and acted in a fair manner. Clients testify to his fairness and kindness even though the Order may have not entirely in their favor.

Even though Corvid-19 has affected all our lives and the speed of court proceedings, Judge Grubich's court runs extremely efficient. Judge Grubich schedules family law hearings and replies to motions in a timely manner. CCLC clients are always surprised when a hearing is scheduled in a reasonable amount of time. They expect a hearing or court ordered- mediation six months or more after filing. Judge Grubich seems to realize, that especially in family law, moving court proceedings in a timely fashion, lets people get back to their lives.

Judge Grubich, William Bronson, (CCLC Executive Director) and I are collaborating on a Parenting Orientation Forum for the Eighth Judicial District. This program is following the model of the Fourth Judicial District's Parenting Plan Orientation. Judge Grubich volunteered and became the liaison between our committee and the judges at the courthouse. Judge Grubich presented our proposal, outline and handouts to the other judge for their in-put. Not only did Judge Grubich proof all the paperwork, he made sure to insert the different judges' opinions and thoughts. Without Judge Grubich bringing together many different people's opinions and wishes, this program could not have moved forward.

He works efficiently and conscientiously with all personalities and opinions to make this program a reality in our court district in the future.

I strongly encourage you to consider Judge David Grubich for the next Eighth Judicial District Court Judge. To those of us who are outside the legal community, Judge Grubich has been a wonderful example of what we think a Judge should be. Kind, compassionate, empathetic, knowledgeable of the law and using commonsense in administering that law.
