The 2020 pandemic requires the court act to protect the public from virus exposure. Until the pandemic has passed, the Clerk of the District Court's offices in all courthouses will be operated so as to eliminate human interaction with the public. Eliminating the physical transfer of paper will limit virus transmission.

IT IS ORDERED the Clerk of District Court Offices are PHYSICALLY CLOSED TO THE PUBLIC, but open for business to the public under the following parameters:

1. The public can review records by calling or e-mailing the request and having the clerk, through fullcourt, e-mail the party the requested documentation. First sending the register, then followed by individual document requests.
2. Documents can be filed by e-mailing scanned copies of documents to the Clerk of the District Court. Originals should follow by usps mail.
3. Filing fees can be paid by credit card. For Daniels County, contact the clerk.
4. Documents that are physically delivered will be quarantined until the CDC time-frame for virus survival on paper has passed.
5. Marriage License applicants should make arrangements in advance with the Clerk of Court.

During this period of quarantine, the extra fees for these requests, copies, printing and payment form will be waived.


