

On August 1, 2024, the Defendant appeared from the Crossroads Correctional Center via Zoom videoconference before the Sentence Review Division of the Montana Supreme Court at the time set for a hearing to review his sentence. Defense Counsel, Tyler Dugger, was also present and appeared via Zoom videoconference.

At the outset of the hearing, Defense Counsel made an oral motion to vacate the Sentence Review hearing and dismiss with prejudice the Defendant’s Application for Review of Sentence filed on March 4, 2024. The Defendant verbally verified his desire to waive his right to sentence review.

Therefore, it is the unanimous decision of the Sentence Review Division that the Defendant WAIVED his right to sentence review and his Application is **DISMISSED WITH PREJUDICE**.
