On September 30, 2022, the Defendant's Application for review of that sentence came on for hearing by Zoom videoconference before the Sentence Review Division of the Montana Supreme Court (hereafter "the Division"). The Defendant appeared from the Passages Pre-Release Facility and was represented by Tyler Duggar, Defense Counsel. The State was not represented.

At the outset of the hearing, Defense Counsel informed the Division that he visited with the Defendant prior to the hearing and that she stated she wished to waive her right to review of her sentence. Mr. Duggar made an oral motion to vacate the Sentence Review hearing and dismiss with prejudice the Defendant's Application for Review of Sentence. The Defendant verbally verified her desire to waive her right to sentence review.

Therefore, it is the unanimous decision of the Sentence Review Division that the Defendant WAIVED her right to sentence review and her Application is **DISMISSED WITH PREJUDICE**.
