On November 3, 2022, the Defendant's Application for review of sentence was scheduled to be heard by the Sentence Review Division of the Montana Supreme Court (hereafter "the Division") by Zoom videoconference. The Defendant was not present from the Missoula Assessment and Sanction Facility. Teal Mittelstadt, Defense Counsel, was present. The State was not represented.
