On May 5, 2023, the Defendant's Application for review of sentence was scheduled to be heard by the Sentence Review Division of the Montana Supreme Court (hereafter "the Division") by Zoom videoconference. The Defendant appeared from the Montana State Prison and was represented by Helge Naber, Defense Counsel. The State was not represented.

Before hearing the application, Mr. Naber informed the Division that he did not have a chance to visit with the Defendant due to his schedule and a jury trial and asked that the sentence review hearing be continued to allow him additional time to meet with the Defendant to prepare for his sentence review hearing. The Division found that the Defendant was not in a position to consent to the continuance due to his state of mind.

IT IS ORDERED that the Defendant's sentence review hearing is **CONTINUED** to the next available hearings scheduled for August 3 - 4, 2023. Notification will be sent to interested parties at least thirty (30) days prior providing the actual time and date of the hearing.
