REVIEW HEARING**

On November 2, 2023, the Defendant's Application for review of sentence was scheduled to be heard by the Sentence Review Division of the Montana Supreme Court (hereafter "the Division") by Zoom videoconference. The Defendant appeared from the Montana State Prison and was represented by Helge Naber, Defense Counsel. The State was not represented. Hon. Jason Marks was present.

Before hearing the application, the Division asked the Defendant if he had an opportunity to speak with his attorney about sentence review. The Defendant stated that he had been trying to contact counsel for one year and eleven months with no success. Mr. Naber informed the Division that he was assigned as counsel in February 2023, but did not have a chance to visit with the Defendant over the phone or live with him. Mr. Naber stated he filed a memorandum with Division but had not discussed the memorandum with the Defendant or provide him a copy. The Defendant requested that his hearing be continued to the next available sentence review hearings to have an opportunity to meet with Mr. Naber. The Division informed Mr. Naber to contact Shelly Smith, the Office Administrator for the Division, if he encounters any difficulty in scheduling a time to visit and meet with the Defendant.

IT IS ORDERED that the Defendant's sentence review hearing is **CONTINUED** to the next available hearings on the Division's **February 1 - 2, 2024** calendar. Notice to the interested parties will be sent at least thirty (30) days prior to hearing giving the actual date and time of hearing.
