On November 14, 2024, the Defendant's Application for review of sentence was scheduled to be heard by the Sentence Review Division of the Montana Supreme Court (hereafter "the Division") by Zoom videoconference. The Defendant was not present. Teal Mittelstadt, Defense Counsel, was present. The State was not represented.

Before hearing the application, Ms. Mittelstadt informed the Division that she recently spoke with the Defendant, and he informed her he was going to be getting out of the Watch Facility and wanted to wait to discuss his case with her after he was released. Ms. Mittelstadt said the Defendant had not contacted her since his release and requested that the sentence review hearing be continued to the February 2025 hearings to have additional time for the Defendant to contact her to discuss his case for sentence review.

It is the majority decision of the Sentence Review Division that the application for review of sentence is **CONTINUED** to the next available hearings on February 6 – 7, 2025. Hon. John Warner dissented as the Defendant failed to appear or contact his attorney. Notification will be sent to interested parties four weeks prior providing the actual time and date of the hearing.


