
On November 14, 2024, the Defendant appeared from the Montana State Prison via Zoom videoconference before the Sentence Review Division of the Montana Supreme Court at the time set for a hearing to review his sentence. Defense Counsel, Tyler Dugger was not present. The State was not represented.

Prior to the hearing, Mr. Dugger informed the Division of an unforeseen emergency situation that would prevent him from attending the scheduled sentence review hearing. The Division informed the Defendant that due to Mr. Dugger’s inability to attend the hearing, the hearing will administratively be continued to the next available round of hearings to allow Mr. Dugger to be present.

IT IS ORDERED that the Defendant’s sentence review hearing is **CONTINUED** to the next available hearings on February 6 – 7, 2025. Notification will be sent to interested parties at least thirty (30) days prior providing the actual time and date of the hearing.


