

On November 14, 2024, the Defendant's Application for review of sentence was scheduled to be heard by the Sentence Review Division of the Montana Supreme Court (hereafter “the Division”) by Zoom videoconference. The Defendant appeared from the Montana State Prison and was represented by Teal Mittelstadt, Defense Counsel. The State was not represented.

Before hearing the application, Ms. Mittelstadt informed the Division that she had visited with the Defendant and found there were three other Applications for Review of Sentence that were filed on April 8, 2016 in Defendant’s Yellowstone County cases DC-14-276, DC-13-758, and DC-13-339 that were never scheduled for a sentence review hearing. The Sentence Review Division never received the Applications as the Defendant filed an appeal in DC-13-339 and filed Motions to Withdraw his guilty pleas after being sentenced on March 25, 2016. Ms. Mittelstadt asked that the sentence review hearing in this matter be continued to the next available set of hearings so that the other cases could be included to be reviewed at the same time.

IT IS ORDERED that the Defendant's sentence review hearing is **CONTINUED** to the next available hearings on February 6 – 7, 2025. Notification will be sent to interested parties at least thirty (30) days prior providing the actual time and date of the hearing.
