

Defense Counsel, Scotti Ramberg, was also present. The State was not represented.

Before hearing the application Defense counsel informed the Division that the Defendant wishes to file an out of time appeal. The Defendant verbally verified his wish to file an out of time appeal.

IT IS ORDERED that the Application for Review of Sentence that was filed August 30, 2024, is **dismissed without prejudice**. Pursuant to Rule 2, Rules of the Sentence Review Division of the Supreme Court of Montana, the Defendant shall have Sixty (60) days following the Decision of the Appeal during which to file an Application for Review of Sentence with the Valley County Clerk of District Court.
