**NOTICE OF ENTRY OF INTERLOCUTORY DECREE AND NOTICE OF  
AVAILABILITY**

The Montana Water Court has entered the Interlocutory Decree for Basin 43B. The Interlocutory Decree includes 711 water right claims. The only water right claims in the Interlocutory Decree are those not previously decreed by the Water Court or have issues that still need to be addressed. The Interlocutory Decree does not include water rights that were fully adjudicated in the Temporary Preliminary Decree or Preliminary Decree.

- If an abstract is included with this notice, then your claim **is** part of the Interlocutory Decree.
- If an abstract was not included with this notice, then your claim **is not** part of the Interlocutory Decree.

If you believe any water right claims in the Interlocutory Decree do not reflect historical (before July 1, 1973) beneficial use, you should file an objection by **September 14, 2026**. Objections must be filed on the forms provided by the Water Court. A request to extend the objection deadline must be filed by **September 14, 2026**. If an extension is granted it will be advertised in the *Livingston Enterprise*, *Big Timber Pioneer*, and *Billings Gazette*.

**WHAT'S NEXT?**

The Water Court will be offering informal public meetings to explain the objection process on the following dates:

- **Wednesday April 29, 2026, at 6:00 pm in person** at Park County Fairgrounds (Dining Room), 46 View Vista Dr. Livingston, MT 59047.
- **Thursday, May 21, 2026, at 12:00 pm via Zoom**. If someone objects to any of your water right claims, the Court will notify you, and you will be allowed to file a counterobjection. After all notice periods have passed, the Water Court will address all

objections, counterobjections, and issue remarks. **Make sure your address is up to date with the DNRC.**
