### FINDINGS OF FACT

- 1. The record owner of claims 40A 202011-00, 40A 202012-00, 40A 202013-00, 40A 211946-00, and 40A 30105876 is 5 Seas Ranch, LLC.
- 2. Claims 40A 202011-00, 40A 202012-00, 40A 202013-00, 40A 211946-00, and 40A 30105876 were decreed with various DNRC issue remarks.
- 3. No objections were filed to claims 40A 202011-00, 40A 202012-00, 40A 202013-00, 40A 211946-00, and 40A 30105876.
- 4. Claims 40A 202011-00, 40A 202012-00, and 40A 202013-00 were decreed with the following point of diversion listed on "Timber Creek":



HOWEVER, THERE APPEARS TO BE ANOTHER DIVERSION ON AN UNNAMED TRIBUTARY OF TIMBER CREEK WHICH IS LOCATED IN THE NWSESE SEC 36 TWP 11N RGE 17E WHEATLAND COUNTY.


6. Claim 40A 30105876 was filed on May 4, 2016 and the following remark was decreed on the claim:

THIS EXEMPT CLAIM WAS FILED ON 05/04/2016. THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 40A DECREE ISSUED 05/07/1985.

7. An Order Setting Filing Deadline was issued indicating that based on the record, it appears the following changes should be made to the source and points of diversion for claims 40A 202011-00, 40A 202012-00, 40A 202013-00, and 40A 211946-00, resolving the issue remarks:



And based on the record, it appears the following change should be made to claim 40A 211946-00, addressing the issue remarks:



A deadline was set for the Claimant to agree or disagree with the proposed changes. The Order indicated that if nothing was filed by the Claimant by the deadline, this Master would conclude the Claimant agreed with the proposed changes, and a Master's Report would be issued. The Order included the following language:

Failure to comply with the terms of this Order may result in sanctions, <u>up to and including entry of default and termination of a water right claim or dismissal of objections</u>. Rule 22, W.R.Adj.R.

Nothing was filed by the deadline.

## **CONCLUSIONS OF LAW**

1. The Water Court is required to address all issue remarks that appear on a claim as well as any objections the claim receives. Sections 85-2-233, 85-2-247, and 85-2-248, MCA.

- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.
- 3. Pursuant to Rule 22, W.R.Adj.R., if a claimant, objector, or intervenor fails to appear at a scheduled conference or hearing or fails to comply with an order issued by the Water Court, the Water Court may issue such orders of sanction with regard thereto as are just.

## RECOMMENDATIONS

- The claims in this Case should be modified as shown in Finding of Fact No.
  - 2. The issue remarks should be removed from claims 40A 202011-00, 40A 202012-00, 40A 202013-00, 40A 211946-00, and 40A 30105876.

Post Decree Abstracts of Water Right Claims are served with the Report to confirm that the recommended changes have been made in the DNRC's water rights database.
