MASTER'S REPORT

The above captioned claims appeared in the Basin 41A Preliminary Decree. On April 5, 2021, the Court received a *Memorandum* from DNRC Water Resources Specialist Myles VanHemelryck regarding ownership update divided interest applications ("641 applications") for each claim.

FINDINGS OF FACT

1. As noted above, Mr. VanHemelryck filed his *Memo* detailing eleven 641 applications for the above captioned claims on April 5, 2021. Attached with the *Memo* were the 641 applications, addendums showing retained and acquired parcels, current DNRC General Abstracts of the water rights requested to be divided, maps showing all required elements, and a deed filed on January 11, 2021, in Beaverhead County.

2. Along with the above-listed attachments, Mr. VanHemelryck's *Memo* contains proposed abstracts for detailing the requested splits containing the following information for each parent and child right to be generated¹:

3. In addition to the requested splits proposed in the abstracts above, the *Memo* addresses a clerical error found in place of use no. 14 of claim 41A 29237-00. To correct the error, the *Memo* attaches the pertinent part of the Master's Report for Case 41A-240 along with an email from William Moore of DMS Natural Resources, LLC, stating that the legal land description should be E2 of Section 13, Twp 12S, Rge 10E, Beaverhead County. Further, the attached Master's Report serves as proof of the state of Montana's non-interest in the proposed parent and child abstracts.

APPLICABLE LAW

1. The Court may split claims into separate claims upon parties' request at any time prior to the issuance of the final decree. Rule 26, W.R.Adj.R.
2. Remarks identifying that a division of a claim occurred may be added to the claims. Rule 26, W.R.Adj.R.

CONCLUSIONS OF LAW

1. The above-captioned claims may be split as requested because the information provided by the 641 forms is complete and sufficient to accurately split the claims as requested in Finding of Fact No. 2. Information remarks appearing on the parent claims denoting that information contained in the abstract of the parent rights was used in the creation of these split claims should be updated to reflect the requested splits of the claims.
2. The place of use element identified on the above proposed abstracts for claim 41A 29237-00 and being split and assigned to claim 41A 30153406 should be corrected as shown in Finding of Fact No. 3.

RECOMMENDATIONS

Based upon the above Findings of Fact and Conclusions of Law, this Master recommends that the Court make the changes specified in the Findings of Fact to correct the Preliminary Decree for this Basin. Post-decree Abstracts of Water Right Claims are

served with this Report to confirm the recommended changes have been made in the state's centralized record system.
