MASTER'S REPORT

INTRODUCTION

The Water Court consolidated water rights claims 41B 88634-00, 41B 88635-00, 41B 88641-00, 41B 88646-00, and 41B 88647-00 into Water Court case 41B-4010-S-2021 to consider whether to split the water rights claims consistent with information in a January 27, 2021 Memorandum (DNRC Memo) filed with the Water Court by the Montana Department of Natural Resources and Conservation (DNRC). The DNRC Memo indicated DNRC received five split request applications (Form 641 applications) from the co-owners of the consolidated water rights—Black Slough LLC and Jerry, Tamara, Kristen, and Cody Meine. On November 12, 2020, DNRC sent deficiency letters requesting copies of the recorded instruments for land transfer, maps depicting the claims' points of diversion, and geocodes for the parcels involved. On November 23, 2020, DNRC received the requested information. Attached to the DNRC Memo are the complete Form 641 applications, including deeds and maps supporting the request to split water rights claims 41B 88634-00, 41B 88635-00, 41B 88641-00, 41B 88646-00, and 41B 88647-00.

The Water Court presently resolves the issues in this case.

<u>ISSUES</u>

1. Whether the Water Court splits water rights claims 41B 88634-00, 41B 88635 00, 41B 88641-00, 41B 88646-00, and 41B 88647-00 consistent with the filed information.

APPLICABLE LAW

"The Montana [W]ater [C]ourt has a statutory obligation and the exclusive authority to adjudicate claims of existing water rights." Rule 1(a), W.R.Adj.R. The Water Court resolves issue remarks before issuance of a final decree and may use information submitted by the DNRC, the statement of claim, and any other data obtained by the court to evaluate a water right. Sections 85-2-227, -231(2), MCA.

The Water Court may split a water right into separate claims, by request or on its own initiative, at any time prior to the entry of the final decree. Rule 26, W.R.Adj.R. A split does not increase any element of an original water right, but serves to accurately reflect the current proportional ownership of the claimed acres irrigated, place of use, volume, and

flow rate. Accordingly, a split does not have the potential to adversely affect other water users' water rights and does not trigger additional notice pursuant to § 85-2-233(6), MCA, MCA. *Circle S Ranch, Inc.*, 2019 Mont. Water LEXIS 8 at ** 4-5. Remarks identifying that a division of a claim occurred may be added to the claims. Rule 26, W.R.Adj.R.

DISCUSSION

1. Whether the Water Court splits water rights claims 41B 88634-00, 41B 88635-00, 41B 88641-00, 41B 88646-00, and 41B 88647-00 consistent with the filed information.

41B 88634-00

Water right claim 41B 88634-00 is a flood-irrigation use right for waste-and-seepage surface water from an unnamed tributary of the Beaverhead River diverted by a headgate in Beaverhead County, Montana. The originally claimed flow rate associated with the water right claim is 3.75 CFS for use on 664 maximum acres.

The DNRC Memo and filed Form 641 applications indicate Jerry, Tamara, Cody, and Kristen Meine, would like to retain 1.88 CFS of the originally claimed flow rate for use on 357.8 acres—10.8 acres in the S2SESE of Section 8, Township 6S, Range 8W, Beaverhead County, 27 acres in the S2SW of Section 9, Township 6S, Range 8W, Beaverhead County, and 320 acres in the N2 of Section 16, Township 6S, Range 8W, Beaverhead County. The Meines will own the parent right—41B 88634-00.
